Executive Director:

Patch Reef Park Pickleball Courts

The asphalt has been applied and will take 30 days to cure, fencing and side work will be done in the meantime. The project is scheduled for completion in February.

Pipes and Pumping Project

The RFP bids are due back on January 27, 2021.

Gumbo Limbo Tower Project

A meeting is scheduled with the City and the Friends of Gumbo Limbo on January 28th.

Needs Assessment Survey

A meeting is scheduled with Pros Consulting Firm and City staff to review the Need's Assessment Survey and discuss the next steps that will be taken.

ILA Amendment

The District is still awaiting a response from the City regarding the ILA Amendment.

Ocean Strand

The permitting/approval process has become complicated. The District is working with the City staff to gather information and continue to move forward.

Palm Beach County Commission on Ethics

Ms. Harms spoke with Mr. Mark Bannon, Executive Director of the Palm Beach County Commission on Ethics, who informed her that the District is not entitled to services since it is an Independent Special District that is governed by the State. A page has been added to the District's website, titled "Ethics", that includes direct links to the Commission on Ethics and its phone number.

Ocean Breeze Bond Payment

The Ocean Breeze Bond payment cannot be paid off early without a penalty until 2027. Ms. Harms will research what the penalties would entail with Mr. Jerry Ford from Ford & Associates.

Swim & Racquet Center

Bolton Perez and Associates has completed an inspection of the pedestrian bridge at the Swim & Racquet Center and has confirmed that it is a safe bridge to use.

Counsel:

Executive Order 20-316

Executive Order 20-316, extending Executive Order 20-52, allowing for hybrid meetings, has been extended for 60 days from December 29, 2020.

Ocean Breeze ILA Amendment

Counsel has not received any communication from the City regarding the amendment to the ILA.

Commissioners:

Commissioner Engel inquired if a written determination from the Chair of the Palm Beach County Ethics Board could be acquired stating that the Palm Beach County Ethics Commission has no jurisdiction over the District as a state agency.

Commissioner Wright inquired if the Board would consider allowing the students at Verde Elementary to use the Swim and Racquet Center's facilities between the hours of 3:00-5:00 p.m. since Verde Elementary does not currently offer any sports programs and possibly

developing the large piece of land owned by the Palm Beach County School District behind Verde Elementary into soccer fields for use by the Verde students and the City of Boca Raton.

MOTION was made by Commissioner Wright and seconded by Commissioner Ehrnst to direct staff to work on an agreement for Verde Elementary to use the facilities at the Swim & Racquet Center and to pursue a separate agreement for the possible development of the green space behind Verde Elementary.
