## **Executive Director:**

# Ocean Strand

Ms. Harms met with City staff and representatives from Maracore Builders to review some maintenance concerns that Recreation Services had at Ocean Strand property. City staff will work with Maracore Builders to get the permitting process moving forward and remove the invasive plants in the next few weeks.

# **Robert Langford Memorial**

Dr. Dennis Frisch, a former BPD Commissioner, contacted Ms. Harms and suggested that the memorial for the former Executive Director, Robert Langford, be placed at one of the remaining blank pedestals that the Rotary Club donated by the Carousel at Sugar Sand Park. The Rotary Club may come forth with dedication suggestions regarding the remaining pedestals.

### Gumbo Limbo Tower MOU

The Friends of Gumbo Limbo asked that the District remove any references, in the Third Amendment to the Tower MOU, regarding splitting the cost of overages between the District and the Friends. If the project does go over the \$1.2 million the Friends will revisit the discussion with the District and the City.

Ms. Harms recommended removing the overage references as to not hold the project up for the Donor Family.

<u>MOTION</u> was made by Commissioner Rollins and seconded by Commissioner Ehrnst to remove the language from the Third Amendment to the Tower MOU that requires the Friends of Gumbo Limbo to participate in half of the overages in the construction of the tower.

### Ocean Strand Title Search

The Title Search Report for the Ocean Strand property identified both the District and the City as joint owners of the three out parcels, however, the deeds from 1994 do not reference joint ownership. Counsel is working with the Title Company to resolve this issue.

Commissioner Rollins believes that the District did purchase the three out parcels at Ocean Strand from the City and received the title to the property. He will research and report back to the Board.
