A draft RFP was presented and reviewed by the Committee. Discussion ensued regarding various revisions to the document.

Mr. Horowitz will make all discussed revisions to the RFP document prior to submitting it to the District Board of Commissioners. If there are no changes requested by the Board of Commissioners the RFP will go before the Board for approval at its meeting on Monday, June 21, 2021. If the Board requests changes to the revised document, the Audit Selection Committee will meet on Monday, June 21, 2021, prior to the District meeting to make the revisions.

Once approved, the document will come back to the Audit Selection Committee on June 22, 2021, at 8:30 a.m. to publicly announce the RFP.
