# 1. RFP Responses for the Operator of the James A. Rutherford Community Center

The District received responses from the YMCA of South Palm Beach County and Zero Empty Spaces to the RFP issued for an Operator of the James A. Rutherford Community Center at Patch Reef Park. The purpose of the RFP was to provide public programming to all residents of Palm Beach County and supplement current recreational programming offered at all Greater Boca Raton Beach & Park District facilities.

Mr. Evan Snow and Mr. Andrew Martineau from Zero Empty Spaces and Mr. Jason Hagensick and Mr. Bryan Hunt from the YMCA each gave a brief presentation of what they would offer to the community and answered questions from the Board.

The Commissioners unanimously ranked the YMCA #1 and Zero Empty Spaces #2. They felt that the YMCA was the best fit for the facility and that its intended uses (summer camps starting in 2022 and additional programs throughout the year such as karate, gymnastics, and engineering programs for children)were more in line with Patch Reef Park and the community. The Board recommended that Ms. Harms negotiate a contract with the YMCA.

**MOTION** was made by Commissioner Ehrnst and seconded by Commissioner Engel to adopt the rankings and recommendations of the Board, YMCA #1 and Zero Empty Spaces #2, and provide direction to the Executive Director to negotiate a contract with the YMCA for the Operator of the James A. ### 2. Patch Reef Park Work Order for Pickleball Courts

Executive Director Harms requested the Board's approval of the Calvin Giordano & Associates (CGA) work order for \$264,520 to do the design, permitting, and construction administration services work to resurface the existing tennis and pickleball courts (converting the current six pickleball courts back to two tennis courts) and adding eighteen new asphalt pickleball courts (including lights) at Patch Reef Park. Ms. Jenna Martinetti (on zoom) and Ms. Robin Verse (in person) from CGA were available to answer questions from the Board.

Discussion ensued regarding the project's timeline(the entire project is estimated to take two years from start to finish), the possibility of keeping the existing tennis courts open on a revolving basis, and any impact it would have on the budget.
