REGULAR BUSINESS:

1. Solar Panels at Sugar Sand Park

At the Greater Boca Raton Beach & Park District meeting held on July 5, 2022, the Board directed staff to research and obtain information on the costs and benefits of adding solar panels to the new roof at Sugar Sand Park Community Center. Staff met with representatives from a local solar panel provider, Freedom Energy, who analyzed the current electric consumption at the community center and the new roof's specifications. The cost would be approximately \$300,000 and the energy savings are estimated at \$1,635 per month. The payback period is estimated at under 12 years and the return on investment may be approximately 7.4% per year. If the Board would like to pursue adding solar panels to the

new roof at Sugar Sand Park Community Center the next step would be to hire CGA to write an RFP and solicit proposals in accordance with Florida Statute 287.057.

MOTION was made by Commissioner Ehrnst and seconded by Commissioner Engel to further explore solar panels and any other options or different features that may be available and that the savings are visibility communicated within the Community Center.

2. Budget Amendment for FY2022

Mr. Merv Timberlake provided a budget amendment for Fiscal Year 2022 and Resolution 2023-01 for the Board's consideration. On July 25, 2019, the District entered into a Memorandum of Understanding (MOU) with the Friends of Gumbo Limbo regarding the boardwalk and tower project at the nature center. Pursuant to the agreement, the Friends donated the first payment of \$250,000 to the District on October 15, 2019. The project was delayed. Under Amendment #5 of the MOU, if construction had not commenced by May 31, 2022, the District was required to return to the Friends of Gumbo Limbo any funds provided by the Friends. On June 6^{th} , the District Board of Commissioners authorized the payment of \$250,000 to the Friends of Gumbo Limbo. The District's 2021-2022 operating budget needs to be revised to appropriate funds for this payment.

Mr. Sam Goren, District Counsel, read Resolution 2023-01 amending the budget for Fiscal Year 2021-2022 into the record.
