1. Sugar Sand Park Carousel Discussion

The District hired Mr. Joe Cadmus, from Mind Changing Entertainment to provide a scope of required work for the carousel at Sugar Sand Park. After his team did a comprehensive inspection, they noted severe deterioration in the gearboxes and the metal poles attached to the interior beams of the carousel. The State Bureau of Amusement Park Rides recommended that the ride be closed until the repairs have been made. Executive Director Harms requested approval to order the parts needed for the repair in an amount not to exceed \$100,000, then put out an RFP to hire someone to do the actual repair work on the carousel.

The work order includes design, permitting, and construction administration services for the preparation of construction documents for the proposed tennis courts resurfacing and lighting improvements

Ms. Harms advised that she wants to add language to the work order stating that in the event of any conflicts between this work order and the original agreement between the District and CGA dated November 15, 2021, the original agreement shall prevail.

Discussion ensued regarding the amount of the original design budget; the hourly rate schedule; staying on task while managing multiple projects; making the City aware of the Districts plans for pickleball; and the need to upgrade the electrical system.
