#### **REGULAR BUSINESS:**

## 1. Gumbo Limbo ADA Parking and Access Project

Originally the ADA parking spaces and access ramp connection to the boardwalk were to be completed with the Tower Project prior to the initiation of the Gumbo Limbo Master Plan project. The City is seeking District approval to move the ADA parking spaces and access ramp connection projects from the Tower project, which has been postponed seeing if prices will come down, to the Gumbo Limbo Master Plan project. The estimated cost will be \$81,612.

Discussion ensued regarding the tower project and its timeline; concern for getting the project done for the donor's sake; the MOU with the Friends of Gumbo Limbo (currently known as the Coastal Stewards of Gumbo Limbo); The Coastal Steward's support of the tower project being broken out so the tower project would not include the infrastructure costs; bidding everything in components and having it valued engineered; the reason for breaking up the bid; setting precedence if the bid is split up; concern regarding the City's commitment to rebidding the tower project or it being further delayed.

Mr. Greg Stevens, Recreation Superintendent for the City of Boca Raton, called in through zoom to explain the project and answer questions.

**MOTION** was made by Commissioner Ehrnst and seconded by Commissioner Vogelgesang to rebid the entire tower project including the ADA access and parking. The bid should allow contractors to bid on the entire project or just portions of it and solicit contractors' suggestions for value engineering the project to reduce the scope and cost.

## 2. Ocean Strand Update

Maracore Builders, LLC was notified of approval from both the City's Planning and Zoning Board and City Council for the concept plan for Ocean Strand. They reevaluated the pricing of the project based on the new conditions established during the approval process. The increase to the overall budget for the development of Ocean Strand Park for FY2022 is approximately \$150,000. If approved, this would bring the budget allocation amount from \$300,000 to \$450,000.

**MOTION** was made by Commissioner Ehrnst and seconded by Commissioner Engel to increase the Ocean Strand budget by \$150,000, for a total project budget of \$450,000.

## **Discussion:**

Commissioner Rollins requested that the park benches and picnic tables be anchored down to prevent movement and/or injury. He inquired if the District received an official notification from the State of Florida clearly stating that Ocean Strand is an archeological site. Director Harms explained that having an archeological representative present to monitor the removal of certain species/items was recommended in the report, but not required by the archaeologist and that it was one of the City's approval stipulations.

Commissioner Vogelgesang inquired about the maintenance costs at Ocean Strand Park and the procedure if there were a storm and items were not anchored down.

Commissioner Ehrnst requested that items like benches and signage be consistent with other Boca parks and that they are of higher quality.

#### 3. Red Reef sail Pavilion and Restroom

As part of the City's budget requests for FY2022, the District approved the Red Reef Sail Pavilion Replacement for \$100,00 and the Red Reef South Restroom Renovations for \$208,000 for a total of \$308,000. The City has requested an increase to the CIP budget for these projects by \$107,000 based on bids they received back. The new total will be \$415,000.

**MOTION** was made by Commissioner Ehrnst and seconded by Commissioner Rollins to increase the previously approved CIP budget of \$308,000 for the Red Reef Sail Pavilion Replacement and the Red Reef South Restroom Renovations by \$107,000, for a total of \$415,000.

#### Discussion:

Commissioner Rollins noted that the District needs to be cognizant of what the requests for an increase in funds are doing to the long-term implications of District projects and would like support if the District needs to increase its millage rate.
