Executive Director:

Boca Teeca

Director Harms noted that the District received an email from a Boca Teeca resident who was very appreciative of the clean-up and recent improvements that have been made to the Boca Teeca area. The email mentioned that Melissa Dawson offers outstanding resident support. Ms. Harms thanked Ms. Dawson for all her challenging work, managing CSR, and doing an excellent job getting the project done.

Ocean Strand

The Ocean Strand site plan and the conditional use plan were both approved at the Planning and Zoning meeting last week with a 3-2 vote on each plan. The conditional use application will go before the City Council for approval at a future meeting.

Director Harms addressed the following comments that were made at the Planning & Zoning meeting by a member of the public:

Public Comment #1: The District does not subscribe to the Palm Beach County Ethics Commission.

Director's Response: In January of 2021 Executive Director Harms reached out to the Director of the Palm Beach County Ethics Commission and was informed that since the District is an Independent Special District, the PBC Ethics Commission could not offer services to the District. The District is monitored by the State Ethics Commission. After learning that the District could not join the Palm Beach County Ethics Commission, a page was added to the District's website with links for information on the Florida Commission on Ethics and information on how to file a complaint or call the Commission directly.

Public Comment #2: The Executive Director and the District Commissioners do not file the annual Financial Disclosure Forms.

Director's Response: Every member of this Commission and the Executive Director files the necessary annual Financial Disclosure Forms.

District Counsel:

Mr. Goren advised that the Temporary Construction Easement for Ocean Strand has been recorded in the Palm Beach County public records. All fees, costs, and expenses have been paid as well as the voluntary contribution of \$15,000.

Commissioners:

Commissioner Wright inquired if the District Board would be interested in partnering with the School Board to build practice fields at the new elementary school that is being built in the fall. She commented on the Planning and Zoning meeting and inquired if anyone heard feedback on the Boca Raton Country Club golf course.

Commissioner Engel commented on the Planning and Zoning meeting.

Commissioner Ehrnst will attend the Federation meeting to represent the District. He believes that the District Board needs to be represented at the City Council and other meetings that are held. He commented on the Planning and Zoning meeting, pickleball, beach volleyball, and the need to support the American Disabilities Act in all District projects.

Commissioner Rollins inquired when the Ocean Strand conditional use application will go before City Council. He commented on the recent Planning and Zoning meeting. Mr. Rollins noted that the city staff is doing a great job with the scheduling and maintenance of the District facilities.

Commissioner Vogelgesang commented on supporting special needs in the community and requested that My PR Guru have more community involvement with the upcoming visioning workshops.
