Mr. Jeff Smith, resident, and member of the Boca Raton Advisory Committee for Parks and Recreation supports mountain bike trails and offered to lead a team of volunteers to construct and maintain mountain bike trails at Ocean Breeze.

He suggested that the Board hold off on approving the \$888,575.00 for the Miller Legg Work Order to design the east side of the property until they have more clarification on the ability to convey the property.

1. Proclamation for Lin Hurley

Mrs. Hurley has been a volunteer and advocate for the special needs community for over half a century and has served Boca Raton for over twenty years as a volunteer with TopSoccer. The Board recognized Mrs. Hurley for her many contributions to the Boca Raton community and presented her with a framed proclamation to thank her and express appreciation for her dedication to the community.

2. Bond Counsel Review

In December 2022, the Board approved hiring Ms. JoLinda Herring of Bryant, Miller, Olive Law firm as special bond counsel to analyze the Ocean Breeze bonds and prepare an opinion on property development opportunities, including Private Public Partnerships (P3s) and discuss legal and Internal Revenue Tax Service restrictions related to the bonds with regard to the District's Charter and Enabling Legislation.

Jo Linda Herring and Will Milford of Bryant Miller Olive Law firm were available via Zoom to discuss and answer questions regarding the Ocean Breeze Bond, P3 transactions, tax restrictions, and a judicial process called Validation. They offered the following three development opportunities for the District to consider:

- 1. Management Contract
- 2. Nonprofit 501(c)(3) Manager
- 3. Redeem the Bond or Amend to a Taxable Rate

The second change order (#18) is to install 600LF of new split rail fencing on the eastern portion of Ocean Strand for \$20,385.00.

Commissioner Rollins thanked Councilman-elect Marc Widger for attending the meeting and commented on what a wonderful person Lin Hurley is.
