REGULAR BUSINESS:

1. Don Estridge Track Resurfacing

Mr. Bruce Rich, Track & Cross-Country Coach at Don Estridge Middle School, asked the Beach & Park District Board of Commissioners (BPD) to consider renovating and resurfacing the existing 6-lane running track located at Don Estridge Middle School. The BPD currently has an Interlocal Agreement with the School Board that provides the BPD and its user groups exclusive use of the facilities at Don Estridge after 5:30 p.m. on weekdays. The BPD has no obligation under its current ILA to renovate or resurface the track.

Mr. Rich stated that the parents at Don Estridge are willing to fundraise to contribute to the cost of the project. Executive Director Harms is waiting to hear back from Kristin Garrison, Director of Planning and Intergovernmental Relations, and Mr. Barbieri, Palm Beach County School Board President, to discuss their plans or contribution to the track.

A proposal for \$250,285 from CSR Construction to renovate and resurface the track was provided to the Board. Mr. Paul Arcel, President of CSR Construction was available to answer questions from the Board.

Discussion ensued.

MOTION was made by Commissioner Ehrnst and seconded by Commissioner Rollins for the Beach & Park District to offer up to \$125,000 towards the Renovation & Resurfacing of the track at Don Estridge Middle School providing open access to the public for the use of the track without any restrictions outside of school hours and when the track is not being used for school purposes.

Mr. Art Turpel committed the members of the Pickleball Club to go to a City Council meeting and let them know the need for pickleball courts and that the construction of the courts is being held up by the city's process.

City staff provided a proposal for the operations of the Pickleball Facility at Patch Reef Park. The Board agreed to go out for an RFP for the operations to keep all options open.
