Mr. Raul Travieso thanked the Board for its efforts in building the Pickleball courts at Patch Reef Park for their constituents. He reviewed the pickleball participation numbers at Patch Reef Park for the last three years which have doubled each year and participation at the indoor courts at Sugar Sand Park is reaching 10,000 participants annually. Members of the Boca Raton Pickleball Club are going to attend the City Council workshop on May 8th to request the Council's support and assistance on this project.

Executive Director:

Futsal

Coastal Stewards

The City of Boca Raton and the Coastal Stewards finalized the Sea Turtle Rehab Program agreement at Gumbo Limbo. Executive Director Harms met with Mr. Holloway who mentioned that they are starting the process to work on obtaining the permit to bring the sea turtles back to Gumbo Limbo.

Sugar Sand Park Roof Replacement

The roof replacement at the Community Center is anticipated to begin on May 8, 2023, once the permits have been issued.

Swim & Racquet Center-Renovations and Lighting Project Update

Weather permitting, the footers for the lighting project should be installed this week. A punch list should be ready by the end of the month.

District Counsel:

Ocean Strand Permanent Easement

District counsel prepared the document directed by the Board regarding the permanent easement at Ocean Strand and sent it to Mr. Abrams for review with his client and the City attorney's office. Mr. Goren advised that discussions regarding the document are still taking place between the City and Mr. Abrams and his client at this time.

House Bill 199- Ethics Requirements for Officers and Employees of Special Tax Districts

Mr. Goren informed the Board that House Bill 199 may pass and will require yearly ethics training beginning January 1, 2024. He advised that his law office is available to conduct the training.

Senate Bill 774-Ethics Requirements for Public Officials

Senate Bill 774 passed both the House and the Senate. Mr. Goren advised the Board that it does not include Special Districts.
