Mr. Goren, District General Counsel, advised that under current law, it is not a requirement under Ch. 286, FS (the Florida Sunshine Law) to have a public meeting streamed or to allow online participation, via what is known as 'Communications Media Technology' as may be the case with certain other governmental agencies. The public must attend the meetings in person to express any comments or concerns.
