#### **REGULAR BUSINESS:**

#### 1. Sugar Sand Park Roof Bids Results

On December 2, 2022, the District received bid proposals from five contractors to replace the Sugar Sand Park Community Center roof. The proposals from A-1 Property Services, PSI Roofing, Atlas Apex Roofing, Advanced Roofing, and Alpha Roofing Sheetrock and Metal were sent to the District's consultant, Calvin Giordano & Associates (CGA) for evaluation and a recommendation. CGA recommended awarding the bid to the second-lowest bidder, Advanced Roofing for \$1,639,586.00. Advanced Roofing was both responsive and responsible according to the RFP.

Mr. Horowitz, District counsel, noted that the District is not required to engage the lowest bidder but can determine the most responsive and responsible bidder in the best interest of the District.

Mr. George Servantes, the project manager from CGA was present to answer questions from the Board.

MOTION was made by Commissioner Rollins and seconded by Commissioner Engel to approve the recommendation of the District's consultant (CGA) to award the bid to Advanced Roofing for \$1,639,586.00 for the Sugar Sand Park Community Center Roof Replacement project.

### 2. Boca Teeca Bond

Mr. Jacob Horowitz, District counsel, stated that the District recently received a package from the City that included pertinent documents regarding the Boca Teeca bond transaction. He requested consideration from the Board to engage Ms. JoLinda Herring, with the Bryant Miller and Olive Law Firm, as Bond Counsel for the District. The Bond Counsel would assist with an analysis of the Boca Teeca Bond and prepare their own separate opinion as it relates to all of the different opportunities for the development of the property with regard to the District's Charter and Enabling Legislation.

Discussion ensued.

The Board agreed that the focus of the bond review should only be on the west side of the property, define if the bonds will allow for the development of the west side, and determine if the development would trigger a taxable event of the bonds. The Board would also like clarity on what terms the District can use when soliciting a Request for Proposal for the west side of the property.

<u>MOTION</u> was made by Commissioner Ehrnst and seconded by Commissioner Vogelgesang to allow District counsel to engage a bond attorney for a term that will be capped at 30 days with an expense limit of \$5,000.

An Amended MOTION was made by Commissioner Engel and seconded by Commissioner Vogelgesang to allow District counsel to immediately hire Bond Counsel for a term that will end on January 30, 2023, with an expense limit of \$5,000 to review the bond from a P3 perspective.
