## **REGULAR BUSINESS:**

## 1. Athletics Staff Presentation on Field Closures

Mr. Greg Stevens, Acting Recreation Services Director for the City of Boca Raton, and Mr. Kevin Beckman, Acting Recreation Superintendent, gave a presentation on the City's field closures policies and how the City determines whether or not a field is playable after it rains or with inclement weather. Mr. Stevens explained that there is a fine balance between making sure that the public has access to the fields, making sure that the fields are safe and playable, and that no long-term damage will be done to the fields.

## Commissioner Rollins joined the meeting via the Zoom platform at 5:22 p.m.

Mr. Kevin Beckman explained the different protocols for closing the clay and rectangle fields. He reviewed the ramifications of playing on wet fields, soil compaction, loss of drainage, the various tools used to help determine closures, and the multiple factors that come into play when deciding if a cancellation is warranted.

## 2. Boca Teeca Conceptual Master Plan Next Steps

Executive Director Harms advised the Board that the current Miller Legg Agreement is nearing the end with approximately \$64,000 in outstanding work to be completed. Director Harms and District Counsel have been in discussions regarding the next steps with Miller Legg and are contemplating the framework of a Public Private Partnership RFP and how agreements might be structured with the limitations that are on the property.

Mr. Horowitz, District Counsel advised that the Miller Legg Agreement can be amended to either increase, decrease or modify the scope of services. Ms. Harms requested direction from the Board on how they would like to proceed, to allow Miller Legg to finish out the scope of services in the current agreement or amend the agreement to include the additional scope of work to start the design work for the east side that the District will fund to develop, operate, and maintain the property. Director Harms advised that this year's budget includes seven million dollars to start the design work on the aspects that the District will build.

#### Discussion ensued.

**MOTION** was made by Commissioner Ehrnst and seconded by Commissioner Rollins to give direction for the Chair and the Executive Director to work with District Counsel to amend the Miller Legg Agreement to facilitate the design and build-out of the east side with a phased approach and continue to explore options on the West side.
