REGULAR BUSINESS:

1. Patch Reef Park Pickleball Discussion

A discussion was held at the September 18, 2023, District Board meeting regarding the potential pickleball facility at North Park and its impact on the pickleball facility contemplated for Patch Reef Park. The District has begun the conversion of two more tennis courts at Patch Reef Park, which will provide an additional six pickleball courts, bringing the total to twelve. An additional three practice pickleball courts will be located apart from the cluster of 12. The project to restructure existing tennis courts with drainage improvements and to construct 18 covered pickleball courts with parking lot improvements has gone out

to bid. Executive Director Harms asked the Board to consider issuing an addendum to the RFP to allow contractors to bid on it as two separate projects, which will break down the cost of the pickleball complex.

Discussion ensued.

It was the consensus of the Board to add the addendum to the RFP and to do a cost analysis of the project.

MOTION was made by Commissioner Ehrnst and seconded by Commissioner Vogelgesang to continue the bid process for the Patch Reef Park pickleball project with an addendum to allow the contractors to bid on two separate projects that will provide individual costs for each component.

Mr. Carl Foster inquired if the budget was already approved for the project and offered to help value engineer the project.

Mr. Cil Ciliberti stated that the "cover" over the courts will always serve a purpose if pickleball gets oversaturated.

Mr. John Silver stated that saturation of the sport is not a concern with all of the "young" pickleball players; the sport will continue to grow.

Ms. Ellen Korelitz offered to form a task force committee to work with the District to review the plans and value engineer the project.

Public Comments closed at 6:22 p.m.

2. CRA Discussion

A brief recap was provided of the District's history with the CRA -the 1986 ILA and the 1989 Amendment to the ILA to help fund the blighted Mizner Park project that was satisfied in 2019. Over time, the District has contributed millions of dollars to the CRA and receives no tax revenue, resulting in non-CRA residents subsidizing CRA residents for amenities. The District's payment has grown from \$1.3 million to \$2.23 million over the past five years. To limit a rapidly increasing loss of revenue, the District applied for an exemption from the CRA

in 2020 and was denied. At a recent Joint meeting with the City Council, the District voiced its concern over the possible extension of the CRA and decided to apply for another exemption.

Executive Director Harms provided the following options for the Board to consider:

- 1. Continue pursuing the exemption.
- Pursue the breach of the ILA for not being consulted on the expenditures of the CRA's budget as outlined in the ILA and for not returning surplus funds per the Florida Statutes. and/or
- 3. Cap the payment to the CRA per the statute.

MOTION was made by Commissioner Ehrnst and seconded by Commissioner Rollins to direct the Executive Director and the District's General Counsel to pursue any and all options to reduce or eliminate the District's increment payment obligation to the Boca Raton CRA by "capping" or exempting the District's payment pursuant to Section 163.187, F.S., and to consider the CRA's breach of the 1986 ILA, as amended, in accordance with Ch. 164, F.S.

Ocean Strand Temporary Construction Easement Change Orders

On November 15, 2021, the District agreed to grant a temporary construction easement on Ocean Strand on the condition that the grantee would restore the vegetation in the easement area and resurface the asphalt service road on the property. The easement was terminated in February of 2023, and the grantee was given notice to follow through on the agreed terms of the easement. The grantee has proposed to reimburse the District for these items. Maracore is under contract for Ocean Strand and has prepared a change order for the work necessary to restore the easement area and renovate the asphalt roadway. Staff recommended approval of this change order contingent upon receiving reimbursement from the grantee prior to work beginning.

Discussion:

Commissioner Ehrnst felt that the amount proposed (\$62,272.00) needed to include the addon alternates presented in the work order and an additional 10% for managing the project. (\$92,000).
