## 1. Budget Discussion

The budget discussion focused on City and District CIP requests for FY 20/21.

Ms. Harms recommended setting up a reserve fund for the Recreation Services Master Plan and Vehicles request totaling \$257,300.

**MOTION** was made by Commissioner Rollins and seconded by Commissioner Wright to set up a reserve fund for the following City CIP projects: Recreation Services (Master Plan) for \$50,000 and Vehicles for \$207,300. Funds will be available for the City to request on an asneeded basis.

A total of \$282,300 will be available for the City to request on an as-needed basis.

District managed projects for 2020-2021 total \$430,000 (a reduction from \$610,000) and include the following:

Patch Reef Park Batting Cages	\$115,000
Sugar Sand Park Asphalt Resurfacing	\$150,000
Swim & Racquet Center Deck Paving Repairs	\$60,000
Swim & Racquet Center Geothermal System	\$90,000
Swim & Racquet Center Restroom Flooring	\$15,000

## Additionally:

#### Ocean Strand

\$100.000 will be carried over for Ocean Strand Phase 1.

#### Beach Renourishment

The Beach Renourishment Fund will be increased by \$300,000.

## **Golf Course**

\$5,000,000 will be allocated for construction of the golf course at Boca Teeca. Ms. Harms recommended that the District establish a Golf Course operation reserve fund of \$250,000.

Discussion ensued regarding the need for pickleball courts.

**MOTION** was made by Commissioner Ehrnst and seconded by Commissioner Engel to convert two (2) tennis courts into four (4) pickleball courts at Patch Reef Park, not to exceed \$25,000.

Discussion: District and City staff will work together on the details of this project. This project will come out of the current budget and will not impact the FY 20/21 budget.

#### 2. Ocean Strand

The District received one (1) response to the Ocean Strand Phase 1 RFP from Maracore Builders, LLC. A design-build was submitted within the District's budget of \$100,000 and all the necessary documents were provided. Ms. Harms is confident that Maracore Builders will build exactly what the RFP required for Phase 1 of the pedestrian park.

**MOTION** was made by Commissioner Wright and seconded by Commissioner Ehrnst to award and accept the design-build RFP bid from Maracore Builders, LLC for Phase 1 of the Ocean Strand project.

#### 3. Ocean Breeze Golf Course -Ongoing Maintenance & Trash Removal

Ms. Harms informed the Board of the increasing amount of code compliance and dumping issues that are taking place at the Ocean Breeze golf course. The cost of ongoing maintenance and trash removal at Ocean Breeze will far exceed the budgeted amount of \$50,000. Ms. Harms wanted to ensure the public that these matters are being addressed and she will work with the City to post official signage; a phone number will be posted for residents to call and report any issues, and a letter will be sent out to the Home Owner Associations asking them to help notify their residents that there is no dumping allowed on the property.

Ms. Harms also noted that the temporary fencing located around the tennis courts and has become problematic and will be taken down. The area will be cleaned up and no trespassing signs will be posted.

#### Golf Course

A 5-year phased approach is still planned for constructing the golf course at Ocean Breeze. Within the first two years 18-holes will be completed and the rest of the project, including the tunnel, will be completed within five years. Mr. Branthwaite, golf course architect, will provide an update at the August 17, 2020 meeting. The District anticipates an answer from the City for the golf course design approval in the next few months.

## **Executive Orders - Virtual Meetings**

On July 29, 2020, Governor DeSantis signed Executive Order No. 20-179 allowing for virtual meetings to be extended through September 1, 2020. A separate provision of the Order allows for TRIM and Budget Hearings to be conducted virtually through October 15, 2020.

#### **Commissioners:**

*Commissioner Ehrnst* expressed appreciation for the work that Ms. Harms has put into the budget. He believes that the District needs to be cautious with its financial commitments and suggested a review of all the District insurance policies.

Commissioner Engel was very satisfied with the Ocean Strand RFP being awarded to Maracore Builders and looks forward to public feedback and speedy completion of the project.

Commissioner Rollins will review all the District insurance programs for possible cost reductions.

*Commissioner Wright* thanked Ms. Harms for her great work reducing the City's proposed budget by \$600,000.

Commissioner Vogelgesang expressed her appreciation towards staff and looks forward to the public input at the Ocean Strand Phase 1 meeting on August 11, 2020.
