# GREATER BOCA RATON BEACH & PARK DISTRICT MINUTES OF THE FIRST PUBLIC HEARING ON PROPOSED 2019-2020 TAXES AND BUDGET SWIM & RACQUET CENTER, 21618 ST. ANDREWS BOULEVARD, BOCA RATON September 11, 2019

### **PRESENTATION:**

### Proposed Millage Rate and Proposed 2019-2020 Budget

Ms. Briann Harms, Interim Executive Director, presented the District's proposed budget for the year ending September 30, 2020. The proposed operating expenditures are **12.3% less than** last year's total operating expenditures. The proposed millage rate is **1.1956 mills.** Ms. Harms reviewed the line-items in the proposed budget. The total appropriated expenditures and reserves for the Fiscal Year 2019-2020 are **\$47,376,300**.

### **PUBLIC COMMENTS AND QUESTIONS:**

*Mr. Richard Lehmann* questioned the proposed increase of 36.7% over current year's budget.

*Mr. Andy Thomson*, City Council Member, believes that a better way to build the golf course would be for the City to build the west side and the District to build the east side of the golf course. In exchange, the City would offer bond financing assistance to help the District complete other capital improvements.

*Mr. Harold Chaffee* stated that the District was formulated to build park and recreation areas and the citizens pay taxes to enjoy these amenities even if they don't utilize every facility.

*Mr. Robert DuKate* opposes the 36% tax increase and fully supports a golf related venue on the east side. He believes that the partnership offer from the City is a commonsense solution to much of the problems.

*Mr. Anthony Ciliberti* supports the millage rate increase and believes that the people of Boca want a better-quality product.

*Donna Kasmer* is concerned that G.L Homes will not close on the sale of Boca Municipal and supports the District building the golf course on its own.

*Mrs. Sue Daddino* supports the tax increase and stated that the District facilities are amazing. She believes that the taxpayer money from the sale of Boca Municipal should go back to into building the new golf course.

*Mr. Al Zucaro* supports the tentative millage rate increase as proposed and supports the District building the course on its own.

*Mr. Rick Heard* supports the increase in millage rate and congratulated the Board for the courage to move forward with the golf course.

*Ms. Laura Vandenbosch* questioned: the last time the millage rate was raised; the costs of upcoming projects and how many years it would take to pay for the projects.
