I. Welcome – Mayor Scott Singer and Chair Susan Vogelgesang

II. Discussion Topic

A. Ocean Breeze Golf Course

Mayor Singer briefly recapped events since the last Joint Meeting. Chair Susan Vogelgesang of the Greater Boca Raton Beach & Park District (District) asked Council for approval of the Price-Fazio golf course design, as the District had unanimously voted to take over the building of the course. District Executive Director Briann Harms and City Manager Leif Ahnell provided additional information regarding recent communication between the two entities. Members and Commissioners debated a number of topics, including, but not limited to, renegotiation of the interlocal agreement (ILA), potential budget impacts and construction timeframe of the proposed golf course. Discussion ensued.

III. Public Comment


